All accounts have been closed with Westpac and from December 2015 onwards, all Club banking will be done with CBA other than amounts transferred to the BT Investment Account. Coaching

Discussion around a better structure around coaching. The Club feels it needs a coaching ethos and better support for specialty coaching resources.

The Club has the money but needs someone to lead the coaching direction.

AGCs have a positive place to play in setting up a coaching structure. But AGCs need to be proactive and attend coaching sessions. Potentially it is an EOI that the Club releases to find a potential Coaching Coordinator who can help build this framework.

Action: Katrina/Grant to approach external parties to ask for advice about how a coaching framework would be set up and who should be setting this up.
